Thank you for your interest in the proper disposal of hazardous waste from your business. Information regarding this program, including a price list follows. The Registration form and the Shipping form need to be completed and returned to our office prior to delivery. The remaining information is for your review.

SEMCO will only accept hazardous waste from businesses determined to be Conditionally Exempt Small Quantity Generators (CESQG's). A CESQG is a business that generates no more than 220 pounds of hazardous waste per month and stores no more than 2,200 pounds on site at any one time.


Our goal is to reduce groundwater contamination through the proper disposal of hazardous chemicals. We are a *non-regulatory* agency and offer this *voluntary* disposal option as a means of realizing our goals.

If you qualify for the program, please call to set up an appointment. At that time we will confirm your generator status and discuss the procedures for accepting wastes into our program. If you have any questions or concerns, please don't hesitate to call us at 319-456-6171.

SEMCO has added a pick-up option available for businesses. This option provides the convenience of no longer needing to arrange or provide both vehicle and driver for a drop off during your normal business operations. Our personnel will arrive at the scheduled time to pick-up your waste and transport it to the SEMCO facility. This option will alleviate the liability, the time and cost of transporting the waste yourself. Your material will be handled by qualified, competent, DOT trained personnel who will assess the risks associated with the material and package it to prevent an inadvertent reaction or spill of your waste during transportation.

## **Procedures for participating in the Conditionally Exempt Small Quantity Generator (CESQG) Hazardous Material Disposal Program.**

### 1. Registration

- a. Your business must fill out a short registration/certification form. This form will certify that you are a CESQG and register your business with our program.
- b. Our staff will then review this form and you will be contacted to set up a time for delivery.

### 2. Shipping Papers

Shipping papers will contain:

- a. The name of the chemicals to be delivered.
- b. The quantity of waste and number of containers.
- c. An emergency contact person with a phone number.
- d. The signature of the CESQG business representative.
- e. The signature of the driver.
- f. Request for pick-up by SEMCO personnel if needed.

### 3. Disposal (Drop off or Pick-up)

- a. Participants must make an appointment for waste disposal.
- b. Appointments must be scheduled in advance.
- c. While making the appointment the participant will need to specify what type of waste and amount that will be dropped off or picked up (number and size of containers).
- d. All containers are to be labeled and must be left with SEMCO.

### 4. Billing

- a. Payment must be in the form of Cash, Business Checks, or Pre-Approved Charge Accounts.
- b. All business transactions must be settled at time of delivery.

## Conditionally Exempt Small Quantity Generators REGISTRATION/CERTIFICATION FORM

I certify that I am a hazardous waste generator within the State of Iowa and because of the small volume of hazardous waste generated and/or stored, I qualify for Conditionally Exempt Small Quantity Generator (CESQG) status. I understand that to qualify for CESQG status, I must meet **both** of the following conditions (as defined by 40 CFR Section 261.5):

1. Generate less than 220 pounds/month (100kg) of all other hazardous waste, and never store more than 2,200 pounds (1,000kg) on the site at any time; and
2. Generate less than 2.2 pounds/month (1kg) of acute hazardous waste, and never store more than this amount on site at any time.

I further understand that if, in the future, I exceed the quantity limitations described above, I will no longer be eligible to participate in this type of collection program.

I, the undersigned, have read the above statements and understand the conditions and provisions that apply to the use of the CESQG Program. I certify that I have the right to make these statements on behalf of my farm or business.
